





At ISW Steel Coated Products Limited (ISWSCPL) We are committed to total customer satisfaction **2.** The warranty shall be valid and applicable for and we take great pride in providing you with quality roofing solutions.

We warrant to the customer whose name appears on this Limited Warranty Certificate herein issued upon completion of valid purchase of our product "JSW Everglow" that JSW Everglow top surface coated with Super Durable Polyesters (SDP) with standard colour coating parameters on Galvalume Steel of minimum 150gsm coating will meet following exterior durability standards during the warranty period subject to the conditions. limitations, disclaimers as set out herein. The Warranty will be applicable for Perforation for a period of 10 years from the date of purchase and estimated performance of Fading and Chalking subject to stipulated terms and conditions including other factors, inter alia, as mentioned in Table 1 below.



This Limited Warranty ("warranty") shall be subject to following stipulations and conditions:

1. This warranty only applies to the product namely "JSW Everglow" of JSWSCPL validly purchased by the purchaser from an authorized distributor / retailer of JSWSCPL only as supplied by JSWSCPL and installed for specified purposes within the Indian territory and not otherwise.

3. This warranty shall not be valid tor applicable or extend to or cover in respect of the following;

- a. installed above 900 meters from sea level. b. product which were formed at a temperature below 18oC in case of coil form supply
- c. product stored or installed in a way which allows contact with animal and / or animal waste or its decomposed products
- d. any claim arising due to failures to remove debris and/or failure to provide free drainage of water including internal condensation from all surfaces of the product
- e. any claim arising due to misuse, willful act / or negligence and footage on erected sheeting / cladding
- f. damages to the products or the paint occasioned, directly or indirectly, by moisture or other contaminations detrimental to the product because of improper storage, packaging, shipping, handling, processing or forming of the product prior to installation.
- g. water damage to the products, directly or indirectly, due to condensation caused by improper storage, handling, processing, forming or packaging of the products prior to installation.
- h. products which has suffered scratching or abrasion or impact by a hard object, has been abused, altered, modified, used in a manner not originally intended or stored contrary to instructions of ISWSCPI
- Non-uniform color changes that results from unequal exposure of roofing, sidewall or trim panels to sunlight and /or the elements are not covered by this warranty unless such

color change meets the definition of the color change as mentioned in 'Annexure-1:

- period exceeding over 6 months from the date of purchase stamped on this warranty
- cut edges and additionally made openings, tension bends etc. during erection /
- uniform change of colour, fading of coating colour, changes in coating colour caused by dust and changes in gloss of coating.

This warranty specifically excludes from its coverage any defects or failures in the exterior durability standards of the product caused by any force majeure events including acts of God (earthquake, fire, storm, floods, torrential rain, cyclone, hailstorm), falling objects, external force, explosions, fire, riots, civil commotions, acts of war. radiation, harmful gases or fumes, chemicals or foreign substances in the air or atmosphere.

12. This limited warranty shall be valid only if it duly signed, sealed and stamped by an authorized distributor/trader of JSWSCL with the date of purchase stamped on this warranty certificate.

13. In event of claim under this limited warranty, purchaser must provide original copy of following:

In addition, the purchaser shall demonstrate to reasonable satisfaction of ISWSCPL that the failure to the product was due to a breach of the limited warranty stated herein.

14.The exclusive remedy under this warranty shall be, at the sole discretion of ISWSCPL to either i repaint the Products: or

ii,provide free of charge replacements (but not installation) for the products with defective paint The purchaser agrees that liability of JSWSCPL is restricted as stated in (i) and (ii) above and shall be sole and exclusive remedy of the purchaser and no other claim for money or otherwise against JSWSCPL and JSWSPCL assumes no other liability or claims or responsibility whatsoever.

15. Any repainted or replaced products shall be subject to this Warranty only for the unexpired period of Warranty applicable to the original genuine product JSW Everglow validly purchased by the nurchaser

16. JSWSCPL shall not in any event be liable for any special, indirect or consequential loss or damages including any claim for loss of profit or business or otherwise to anyone due to the Products with defective paints.

17■JSWSCPL extends this warranty solely to the original purchaser of the product. This Warranty is non-transferable and non-assignable.

18 JSWSCPL reserves the right to terminate at its sole discretion this warranty at any time without a written notice.

19. After expiration of the Warranty Period, this Warranty shall be deemed automatically extinguished forthwith and thereafter no claim shall lie or be acknowledged.

20 This limited warranty shall be governed by and interpreted in accordance with Indian Laws and the courts of Mumbai shall have exclusive jurisdiction with respect to all matters arising from this Warranty between the parties.

Film Integrity shall be defined as the absence o peeling, chalking, chipping or cracking, except for such crazing or slight cracking as may occur on tightly roll-formed edges or brake bends at the time of forming pre-painted sheet.

2_Color Change shall be define as freedom from fade or change as mentioned in Table 1 in terms of with ASTM D 2244-93, CIE "L", "a" "b", 10 degree Observer, specular included. Color change i leasured on an exposed painted surface that has peen cleaned of surface soil and chalk and compared to corresponding values measured on the

original or unexposed coated surface.

3. Chalk shall be defined as a numerical rating as warranted and measured in accordance with the standard procedures specified in ASTM D 4214-98.
